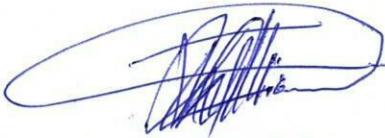

5. **Qualifications requirements:** All bids must be accompanied by;
 - A bid security in the form of a **Manager's check/Bank Guarantee of US\$500.**
 - Valid Tax Clearance
 - Valid Business registration with business activity Code: **C1811**
 - Power of Attorney to act on behave of the entity
 - Must be Registered on the EGP platform
 - Provide proof of ability to pre finance the printing and supply of the booklets
6. Bids shall be valid for a period of ninety (90) days after the deadline of bid submission.
7. All bid must be accompanied by a bid security of US\$500.00 (**Five Hundred United States Dollar**) and shall be valid for a period of Twenty-Eight (28) Days after the tender validity period.

8. **Bids must be submitted on the PPCC eProcurement Platform on or before September 2, 2026, at 3:00pm.**
9. A complete set of Bidding Document in **English** will be available on the PPCC eProcurement Platform by interested bidders.
10. Bids will be open on **September 2, 2026, at 2:30pm**, on the PPCC eProcurement Platform.
